Introduction

The Edith Stein Catholic Academy Trust (ESCAT) is ambitious in its aims; the schools in the Trust are drawn together through their Catholic mission. Directors want them to reap the full benefits of collaboration and sharing of best proven practice.

The Directors believe that schools in the Trust should be distinctive and rooted within their parish and local communities. Directors intend to maintain the distinctive nature of each of the schools, including securing the Charism of any founding order, recognising the communities they serve, whilst sharing good practice across the board to build an established Trust of excellence.

The pupils studying in our schools are entitled to the best opportunities we are able to give them at every stage, from early years to their transition into employment or higher education. Our schools must provide the best quality education to all their pupils, which places the knowledge and love of Christ at the centre of all. The responsibility of the schools within the Trust is, first and foremost, to *"help all its pupils to become saints"*.

Our duty is to prepare our pupils for adulthood, through an ever deepening and transformative relationship with Jesus Christ, that they may discern their true vocation and grow in holiness.

Our strategy is underpinned by a set of common values and beliefs that find their genesis in the Gospels.

THEME A - CATHOLIC LIFE AND MISSION

Aim: Through our faith, promote academic, spiritual, emotional and social growth.

Objectives:

- A1 Provide a Catholic Christian education for all pupils in our schools, creating better citizens now and for the future by nurturing reflective, caring individuals who have a clear moral compass, derived from Gospel values and virtues.
- A2 Through high quality prayer and worship, develop personal relationships with God.
- A3 Provide formation for staff and Governors in all schools to enable them to understand and fulfil their respective roles.
- A4 Nurture strong and positive relationships between the families, the school communities and the parish that are enjoyed by all.

This will be assessed through the annual update of the schools' self evaluations based on the Catholic School Inspection Framework (Section 48).



THEME B - ACHIEVING POTENTIAL

Aim: Ensure the very best teaching the highest quality learning and the very best pastoral support, demonstrating the highest possible standards, to prepare our pupils for the future and deliver the very best possible outcomes for each individual.

Objectives:

- **B1** Ensure ambitious curriculums where each individual experiences the full wonder of the world God created.
- B2 Ensure systems are in place to:
 - Support and promote the wellbeing of all in our schools.
 - Facilitate training and development for staff to enable inspirational teaching and learning.
- **B3** Ensure that academic results meet the challenging targets set by individual Local Governing Bodies, based on the context of each school.
- **B4** Ensure Trust schools develop inclusive pastoral systems supporting preferential treatment of the poor.

This will be assessed through the annual update of the schools' self-evaluations based on the Ofsted Inspection Framework.

THEME C - OUTWARD LOOKING SERVANTS

Aim: Ensure that all involved in the life of the school can become 21st Century Christians who can make a positive contribution to their community, wider society, and the Church and are able to articulate the core principles of Catholic Social Teaching.

Objectives:

- C1 Our schools are to be welcoming places that enable all to engage with the Catholic life and ethos of the school.
- C2 Provide opportunities to those who do not yet know Christ to come to know him.
- C3 Develop greater awareness of the principles of Catholic Social Teaching as defined by CAFOD and how they impact on how we live our lives.
- **C4** Enable staff and pupils to grow in virtue and in their concern for social justice and help them to act responsibly with a social conscience.

This will be assessed through the annual update of the schools' self-evaluations based on the Catholic School Inspection Framework (Section 48) and other external matrices.

THEME D - STEWARDSHIP OF THE ENVIRONMENT

Aim: In the spirit of Laudato Si', all of our staff and pupils to become responsible stewards of God's creation.

Objectives:

- **D1** Our schools will be ethical in their procurement, use of resources and care of the environment. We shall adopt green and sustainability initiatives where appropriate to help meet the challenges of Government targets relating to the environment, and our people will become advocates for change.
- D2 Our schools will raise awareness of the seven principles of Laudato Si' and how it impacts in our lives:



- Response to the cry of the Earth;
- Response to the cry of the poor;
- Ecological economics;
- Adoption of simple lifestyles;
- Ecological education;
- Ecological spirituality;
- Emphasis on community involvement and participatory action.
- **D3** Consistent with the objectives at D2, we shall ensure our infrastructure is maintained to a high standard and take opportunities to improve facilities and, where appropriate, share resources across the Trust.
- **D4** The Trust recognises it has a part in the government target to reduce greenhouse emissions to net zero by 2050. The Trust recognises that whilst the targets are national, Trust schools will engage with local level initiatives contributing towards meeting national targets.

This will be assessed by the criteria of the Oscar Romero Awards and other awards that recognise a schools commitment to the environment.

THEME E - SECURING THE FUTURE OF OUR SCHOOLS

Objectives:

E1 Our Community

- E1.1 Work in partnership and collaboration with Diocese schools, supporting their vision to grow the Trust in the south of the Diocese.
- E1.2 Promote our relationships with partner schools and other external organisations to ensure schools are at the heart of the community to establish an effective model for education and new evangelisation in our area.

E2 Our People

- E2.1 Recruit, develop and retain high quality people who are committed to the mission of the Trust, the Church and Christ-centred education.
- E2.2 Invest In colleagues to identify and grow future leaders in Catholic Schools.
- E2.3 Develop efficient and effective systems and processes at all levels that support, monitor and challenge leadership teams.
- E2.4 Share best practice and coordinate focused professional development.
- E2.5 Challenge LGBs to ensure all staff are supported with both their physical and psychological wellbeing.

E3 Our Resources

- E3.1 Ensure financial stability of each schools through strategic planning with regularity, propriety and compliance so that our stewardship of resources provides the best possible experience for Trust school communities.
- E3.2 Operate an effective financial strategy ensuring long term viability, the ability to invest in current resources and the ability to provide support to Trust schools.
- E3.3 Further development of the common services platform, providing value for money, building capacity and future proofing centralised services.
- E3.4 Actively pursue external funding to maintain and enhance the learning environment to facilitate the delivery of the curriculum.
- E.3.5 Ensure systems exist to share resources to support schools in the greatest need.

This will be assessed through the annual update of the schools' selfevaluations based on the Ofsted Inspection Framework; internal and external scrutiny and good, critical governance.
